



## **Jamaica Trip Online Giveaway OFFICIAL CONTEST RULES**

These rules apply to the **Jamaica Trip Online Giveaway Contest** (“Contest”) conducted by Beasley Media Group, LLC d/b/a WNKS-FM (“Station”). **In addition, the General Contest Rules posted at [kiss951.com](http://kiss951.com) apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

### **1. HOW TO ENTER**

- a. The Contest will begin on April 27, 2026 and end on May 17, 2026.
- b. To enter online, visit [kiss951.com](http://kiss951.com) and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on April 27, 2026 at 12:00am Eastern Time (“ET”) and ending on May 17, 2026 at 11:59pm ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person per day during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) winner selected in the Contest.

### **2. ELIGIBILITY RESTRICTIONS**

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

### **3. PRIZES**

Up to one (1) prize will be awarded. **4-day/3-night All-Inclusive vacation for two (2) adults** to any one of the Sandals Resorts listed below, (*recipient's choice*) (“**Sandals Resorts Accommodations**”) plus

**round-trip coach airfare tickets for two (2) adults to the destination (“Airfare”)** (Sandals Accommodations and Airfare collectively, the **“Sandals Prize Package”**).

1.2 Average Retail Value Sandals Prize Package:

- (i) Sandals Resorts Accommodations = **US \$3,054; and.**
- (ii) Airfare for two (2) adults = **US \$1,000 (capped at \$500 per person).**

**Total Average Retail Value Sandals Prize Package = US \$4,054**

1.3 The Sandals Prize Package is subject to availability and certain blackout dates including but not limited to days pre and post all major US holidays.

1.4 The Sandals Prize Package will be issued in the form of a prize certificate (the **“Prize Certificate”**), outlining the terms and conditions of the Sandals Prize Package and redemption procedures.

Accommodations are valid for one (1) room double occupancy, king size bed deluxe room, all meals, unlimited premium brand liquors, daily & nightly entertainment, an array of land and water sports activities, including daily scuba diving (for certified divers), snorkeling, Wi-Fi in all rooms and public areas, resort taxes, resort gratuities, and Sandals Resorts transfers to and from the resort’s designated airport.

Round-trip coach airfare for two (2) adults valid to/from the nearest major U.S. gateway of the prize winner to the selected or designated resort’s airport. The tickets are valid for the Sandals Prize Package Redemption Period (the **“Redemption Period”**). Flights will be on mutually approved dates. Winner and travel companion must travel on the same itinerary, originating from the same airport. Flights and airlines are subject to change and availability. Restrictions and blackout dates are 7 days before and after any major U.S. Holiday.

The accommodations portion of the Sandals Prize Package is subject to space availability and selected blackout dates. Unique Travel Corp, the worldwide representative for Sandals Resorts (the **“Sandals Prize Package Provider”**) and Sandals Resorts each reserves the right to relocate any confirmed prizewinner from the selected resort to an alternate resort within the resort’s chain and to change dates with prior notice should circumstances so require or for any circumstance(s) beyond the resort’s control. The terms and conditions agreed to by the prizewinner shall apply with equal applicability to any resort which is the subject of

substitution or deviation. Neither Unique Travel Corp nor Sandals Resorts shall be liable for any claim made by the prize winner whatsoever, including but not limited to loss, compensation, or refund by reason of such substitution or deviation.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. In addition, winner and guest(s) should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before, during and after the trip. **Winner will be issued a 1099 for 2026, regardless of when the winner redeemed the prize trip.**

**“Exclusions” – car rental, personal charges, incidentals, telephone calls, Premium Wi-Fi, Red Lane® Spa treatments and services, specialty dining, tours & excursions, inter-island transportation, SCUBA certification courses, room services, meals outside of the selected and/or designated resort, island departure taxes, purchases made at the Sandals Specialty or Gift Shops, baggage fees and customs duties are not included.**

- d. Winners will be announced on the Station on Monday, May 18, 2026 no later than 5:00pm ET and will be notified via phone and/or email promptly following the random drawing. If the winner(s) cannot be contacted within two (2) business days after the prize is awarded, an alternate winner(s) may be selected (time permitting) in a random drawing of all remaining eligible entries.
